
Sub: Payment of Dearness Allowance at revised rate in respect of Board Level as well as below Board Level Executives for the period from 01.07.2014 to 30.09.2014.

In terms of item No. 6 of O.M. No. CIL/C-5A (vi)/005/35/1210 dated 02/07.05.2009, Dearness Allowance is payable from 1st January, 1st April, 1st July and 1st October in every year based on price increase above Quarterly Index Average 126.33 points as on 01.01.2007.
