





ORDER

The committee constituted to resolve issue of Horizontal movement of executives of Mining Discipline from Second Class channel to First Class Mining channel, where the effective date of First Class MMCC of mining executive is prior to deemed date of present grade of executive, gave its recommendations which were approved by the Competent Authority.
