Sub: Implementation of the decision of SLC(LT)'s Meeting held on 12/11/2008.

Dear Sir(s),

Attention is invited to this office letter no. CIL/CMO/47252(New Pol)/246 dated the 19th February 2009 addressed to you on the above subject and also with reference to Minutes of the 06th and 07th CLOA Meeting held at CIL(HQ) on 06/01/2009 and 26/3/2009 respectively with particular reference to item 1 including Annexure - I of 6th CLOA Meeting and Annexure - III of 7th CLOA Meeting. It may please be informed that a decision has been taken for issuance of notice for LOA to submit CG by the Power Utilities / TPSs. For such cases, the documents received from CEA have already been forwarded to you by CIL.

While issuing the notices to the Power Utilities for furnishing CG, compliance shall also be made to the directions of SLC(LT) dated 12/11/2008 vide item 21 seeking to submit CG within 30 days from the date of issuance of notice, stipulating that -

- (i) the LOA will stand withdrawn without any further notice and the project would be reverted back to the pending list of applicants at MOC or failure to comply with the conditions relating to environmental clearance, financial closure, acquisition of land and start of construction within the stipulated period;
- (ii) the milestones in the Model LOA shall be updated by the coal companies in terms of para 21(e) of the SLC(LT) minutes of meeting dated 12/11/08 and
- (iii) the LOA shall be issued within 45 days from the date of the notice subject to receipt of the CG within 30 days from the date of issuance of the notice.

Accordingly, a notice may be issued forthwith to each such TPS unit cleared by CLOA seeking to submit CG within 30 days. The notice for CG must clearly stipulate that in the event the CG in the form of BG is not received within the prescribed date the offer shall be deemed cancelled without any further reference under any circumstances. The notice must repeat must be sent by e-mail, fax as well as by registered post at the appropriate address. Besides, the unit should also be informed over telephone and record of such telecommunication (date/time/name) must be maintained.


