
The scheme for issuance of LoA under NCDP for non-SLC(LT) category consumers with the lapsed linkages for BIFR referred status was communicated vide letter No. CIL/DM/Secy/258 dated 25/27th August' 09. Subsequently the modification in clause 4.0 (source of coal supply) of the above scheme was put up and approved by CIL-Board in its 254th meeting held on 30th January' 10 subject to the confirmation of MOC.

On receipt of the letter from MOC vide No. 23011/41/2008-CPD dated 4th June' 10, the modification was again placed for implementation to Chairman, CIL which was duly approved with the direction that the same may be informed to CIL Board.

The approved modification in the scheme is as below :-


Existing Provision	Modified Provision
Clause 4.0 : "Source of Coal Supply "Company wise coal availability vis-à-vis commitments with net coal balance position should be readily available on CIL/Subsidiary Company's websites for information of all applicants. In case of negative coal balance consumers will be supplied imported coal"	Clause 4.0 : "Source of Coal Supply "Company wise coal availability vis-à-vis commitments with net coal balance position should be readily available on CIL/Subsidiary Company's websites for information of all applicants.
