

Terms & Conditions for Participating in the Competition:

1. The Competition is for Employees of CIL and all its Subsidiaries. Each employee is allowed only one film entry.
2. This is a short film competition and hence ONLY Short Films should be submitted. The entries can also be digital animation films on the topic. The name and identity of the participant should nowhere be indicated on the movie. They will have to fill separate form and send long with the film in different file.
3. DURATION: The films shall not be more than 3 (Three) minutes (180 seconds) within 20 MB. Films exceeding this time limit are liable to be rejected. The minimum length should be 30 seconds.
4. The short films must be in English/Hindi (subtitles may be added if required). Films submitted previously to any other festival/copied from internet/social media will not be considered for this contest. If found later, will be disqualified for the contest/prize withheld. The work should be original in nature and the individual work of the participant. However,

the participants are allowed to take ideas from books, journals, internet and the references must be given by the participants at the end of the video.

5. FORMAT: The films may be shot in MPEG4 or AVI format.
6. Restrictive requirements-The following conditions may be followed while making the film:
 - a. Texts, plots, actions of stage persons and characters from any political field, TV personality etc and should not attempt to outrage the modesty of any gender, religion, caste and community.
 - b. Obscene words (abusive language), words and phrases degrading human dignity, strong expressions and slang, embedded advertising, demonstration of smoking, firearms and cold weapons, explosives, the process of making explosive devices, the use of alcohol and drugs, other psychotropic substances.
 - c. Showing actual addresses and telephone numbers, information on religious movements, including religious symbols, names and references to existing brands of goods, trademarks, service marks, individuals and legal entities.
 - d. Images of fascist paraphernalia (swastika), scenes of violence, any kind of discrimination, vandalism, blood, reflecting the bodily suffering of people and animals, sexually explicit scenes, images of naked people, and other information, degrading in any form a person or a group of people, as well as information that may cause harm to health and (or) child development and containing calls for extremist activities.
 - e. It is not allowed to use other people's texts, videos and audio materials (plagiarism), except for citing works to the extent permitted by the copyright law.
 - f. In case of non-compliance with these requirements, the work will be disqualified from participation in the Contest at any stage.
 - g. Contest works are not to be returned nor reviewed. Once submitted to Vigilance Division, it cannot be taken back for any changes.
7. As the rules are self-explanatory no queries by mail or phone call will be entertained.
8. The entries of contest/ competition will be scrutinized and selected by the Panel of Judges selected by CVO, CIL.
9. The winners will be intimated through the Contact NOs and Email IDs.
10. The Prizes will be given/announced during the closing ceremony of VAW-2020.
11. Once submitted to Vigilance Division, CIL the film will become property of Vigilance Division, CIL and can be used for in house publications and Exhibition or any other purpose.
12. Details of employee in the given format (Annexure-A) may be downloaded, filled, scanned and sent to the provided mail ID along with their short film.
13. The decision of CVO, CIL shall be final in all respects and no claims of any participant shall be entertained.
